## 3. Profile of skills and competences

The skilled bookbinder has shown competence in cutting, folding, stitching and binding printed materials for finished products. Competence includes production planning and preparing, adjusting and servicing machines and equipment. This also includes knowledge and selection of materials. Operating and maintaining bookbinding machines and book-finishing machines and appurtenant production equipment, as well as control checks and error rectification, are included in this competence. The bookbinder is able to plan, carry out, control and register bookbinding assignments in line with quality controls and ordering routines, standards, trade norms, production control systems and current Environment, Health and Safety rules and regulations. Risk assessments and understanding safety and quality enhancement are a part of a bookbinder's competences. This includes, among other things, the safe use of solvents and chemicals, recycling and the reduction of hazardous emissions. A bookbinder's competence involves cooperating with colleagues and other professions within the graphic design industry with requirements for efficiency and reorganisation.

<b>Additional information</b> The training period consists of four years, and can take place as two years at school followed by two years of company based training, or one year at school followed by three years of company based training, or all four years in a company combined with school based training. Two years of the training consists of a total of 588 hours in Common core subjects, 954 hours in Common programme subjects and 421 hours vocational specialization. Adult students with documented five years of work and a passed theoretical exam relevant to the subject, are qualified for a craft certificate examination according to §3-5 in the Education Act. Adult students are exempted from the requirement of common core subjects.
