## 3. Profile of skills and competences

The skilled goldsmith has shown competence in designing, developing, producing and repairing jewellery, jewellery parts and small objects made with noble metals and gems. The goldsmith is able to plan, produce and fit goldsmith products in series or as special products using different materials, machines, tools and older and newer techniques. This competence includes casting, preparing, joining and galvanising. Making and adapting different mountings and jewellery parts and setting gems are included in this competence. Calculating the use of alloys, weights and volumes of noble metals is a part of the goldsmithing profession. The goldsmith is able to use digital aids and tools and to assess, present and document his or her work. The holder of this document is able to communicate with customers and specify and visualise product ideas, designs and working processes pursuant to customer orders. The goldsmith has knowledge of the chemical and physical properties of noble metals and of safety routines for working with stones, gems, pearls and metals. He or she is able to market goldsmith products and calculate production costs for the goldsmithing profession. The goldsmith is able to work in accordance with current rules for Environment, Health and Safety.

| <b>Additional information</b><br>The training period consists of four years, and can take place as two years at school followed by two years of company based training, or one year at school followed by three years of company based training, or all four years in a company combined with school based training. Two years of the training consists of a total of 588 hours in Common core subjects, 954 hours in Common programme subjects and 421 hours vocational specialization. Adult students with documented five years of work and a passed theoretical exam relevant to the subject, are qualified for a craft certificate examination according to §3-5 in the Education Act. Adult students are exempted from the requirement of common core subjects. |                                   |                                      |
