3. Profile of skills and competences

The skilled furniture upholsterer has shown competence in producing and restoring stuffed furniture and interior products. The furniture upholsterer is able to plan furniture production, which includes stuffing and pulling different types of textiles onto the furniture, as well as covering walls with textiles and sewing products and accessories for indoor textiled furniture. Competence includes sewing by hand and machine, carrying out condition assessments of stuffed furniture, taking measurements, cutting and using different materials for stuffing and padding, as well as pulling textiles and assembling pieces. Restoration using traditional methods and materials and the use of spiral springs is also a part of the upholstering profession. The furniture upholsterer is able to use digital tools to present and document work. The furniture upholsterer is able to instruct customers about the need for repairs and restoration of stuffed furniture, and is able to market upholstered furniture products and assess market needs. The furniture upholsterer has knowledge of trends in the craft and of the properties and areas of use for textiles and materials. He or she is able to estimate material and time used and prices for upholstering. The skilled furniture upholsterer is able to work in accordance with current rules for Environment, Health and Safety.

Additional information

The training period consists of four years, and can take place as two years at school followed by two years of company based training, or one year at school followed by three years of company based training, or all four years in a company combined with school based training. Two years of the training consists of a total of 588 hours in Common core subjects, 954 hours in Common programme subjects and 421 hours vocational specialization. Adult students with documented five years of work and a passed theoretical exam relevant to the subject, are qualified for a craft certificate examination according to §3-5 in the Education Act. Adult students are exempted from the requirement of common core subjects.
