3. Profile of skills and competences

The holder of this document has the competence to perform forestry work, forestry operations in keeping with natural tolerance levels and quality assessment of timber. S/he

- has knowledge about forests as ecosystems, as the basis for production and income and as a source of recreation
- has knowledge about sustainable exploitation of wilderness resources
- is qualified to plan the work and select the appropriate methods in relation to forest conditions, multi-use considerations, terrain considerations and economy, and is qualified to use and maintain hand tools, equipment and machinery that are commonly used in the industry
- has knowledge about the most important acts and regulations that apply to forest and wilderness management
- is able to carry out this work in a proper manner bearing in mind health, safety and the environment

The final training in school comprises the modules 1: Silviculture, 2 and 3: Wilderness studies 4: Planning and guidance, 5: Product and sales studies, 6: Business economy, 7: Operations.

The holder of this document also has skills on the upper secondary school level in Norwegian, English, mathematics, natural science, social studies and physical education. Adult students may in some cases be exempted from the requirement for these common-core general studies subjects.

The education/training corresponds to completed upper secondary education	Grading scale / Pass requirements Grades are numerals using the following scale: 6 – 5 - 4 - 3 - 2 – 1 - 0. Grade 6 is the best. Grades 2 - 6 indicate a passing grade. Subjects with examination grades and assessment grades have been passed when the examination grade is 2 or better. "Exempted" may be used instead of numeral grades in some subjects. This means that the pupil/external candidate has previously passed equal or more comprehensive training in the subject. Adults may also have their attained competence assessed instead of receiving a numeral grade. The assessment "Approved" equals a passing grade.
