The holder of this document has the competence to work with the nursing care of various patient groups and their daily chores, participate in community activities and in the general treatment scheme. S/he

- is qualified to carry out basic nursing based on the needs of the patient/user
- has knowledge about common illnesses and their treatment
- is capable of informing and guiding patients/users and family/friends
- is able to communicate with persons of all ages and differing communication abilities
- is qualified to provide practical guidance to auxiliary nurse students and trainees
- is qualified to give care and nursing to patients/users
- is able to carry out this work in a proper manner bearing in mind health, safety and the environment
- has authorization as health care personnel and comes under the Nordic agreement relating to health personnel

The final training comprises the modules 1: Ethics and communication, 2: The working environment, Hygiene, 3: Basic nursing tasks, 4: Mental health care, 5: Infant and maternity care, 6: Disabilities, Social studies, 7: Hospital practice, 8: Open care/home nursing, 9: Elective practice.

The holder of this document also has skills on the upper secondary school level in Norwegian, English, mathematics, natural science, social studies and physical education. Adult students may in some cases be exempted from the requirement for these common-core general studies subjects.
