### 3. Profile of skills and competences

The holder of this document has the competence to work as a surveyor, map designer or cartographer. S/he

- is familiar with the principles behind and the structure of relevant equipment and is capable of checking and maintaining the equipment
- is capable of measuring and setting out points using land surveying equipment (levelling telescope, total stations, GPS etc.)
- knows the principle of the structure of digital maps and is capable of editing them
- is qualified to use GIS software and keep geodata databases up to date
- is qualified to present maps on paper and screen
- is qualified to draw up the basis for aerial photography (placing pass points and making flight plans)
- is capable of inventing points in aerial photographs
- is capable of constructing maps based on aerial photographs using stereo instruments
- masters ICT and relevant software in day-to-day work
- is familiar with the importance of the trade to society
- is capable of adapting to development in the trade

The final training comprises the modules:

Fixed module: 1: Mathematics.

Two of the modules: 2: Surveying, 3: Cartography, or 4: Photogrammetry depending on the school's programme.

The holder of this document also has skills on the upper secondary school level in Norwegian, English, mathematics, natural science, social studies and physical education. Adult students may in some cases be exempted from the requirement for these common-core general studies subjects.

Grading scale / Pass requirements  The grading scale is as follows: 6 – 5 - 4 - 3 - 2 – 1 - 0.  Grade 6 is the best grade. Grades 2 - 6 are passing grades. Subjects with both examination grades and overall achievement grades have been passed when the examination grade is 2 or better. "Exempted" may be used instead of numeral grades in some subjects. This means that the pupil/external candidate has previously passed corresponding or more comprehensive training in the subject. Adults may also have their attained competence assessed instead of receiving a numeral grade. The

The three years of training take place in a school/training centre. This comprises a total of 21 periods per week in general studies subjects, 78 periods per week in specialised subjects and six periods per week in elective subjects. Adult students may in some cases be exempted from the requirement for the general studies subjects.
