The holder of this document has basic competence relating to advertising, illustration and design. S/he

- has knowledge of analysis and problem solution, strategy and idea development (brainstorming), communication processes, genres, marketing, media and their techniques
- has skills relating to creative work, teamwork and individual work
- has visual competence and familiarity with a wide range of visual expressions
- has knowledge of ethical norms, legislation and regulations, as well as health, environment and safety activities
- is capable of using relevant tools
- is capable of controlling a production process

The final training comprises the modules: 1: Advertising, 2: Design, 3: Illustration, 4: Marketing.

The holder of this document also has skills on the upper secondary school level in Norwegian, English, mathematics, natural science, social studies and physical education. Adult students may in some cases be exempted from the requirement for these common-core general studies subjects.

No certificate levels are used in Norway. The education/training corresponds to completed upper secondary education	The grading scale is as follows: $6-5-4-3-2-1-0$. Grade 6 is the best. Grades $2-6$ are passing grades. Subjects with both examination grades and overall achievement grades have been passed when the examination grade is 2 or better. "Exempted" may be used instead of numeral grades in some subjects. This means that the pupil/external candidate has previously passed equal or more comprehensive training in the subject. Adults may also have their attained competence assessed instead of receiving a numeral grade. The assessment "Approved" equals a passing grade.

Training is over three years in a school/training centre. This comprises a total of 21 periods per week in general studies subjects, 78 periods per week in specialised subjects and six periods per week in elective subjects. Adult students may in some cases be exempted from the requirement for the general studies subjects.
